a. In a marriage ceremony, dance was going on from some of the people on the bride's side. One person Ravi- groom's friend commented that the dancers from bride's side look tired now and groom's side people shall start dancing. These remarks irked some members from the bride's family and a heated exchange of words with mutual abuses, immoral slangs took place from both sides in a sudden fight. Mahesh Singh from bride's part was carrying a pistol as a part of their culture. In a fight that broke out between the two sides, he took out the pistol and fired resulting into death of Ravi and two others from groom's side.

Justify whether Mahesh is guilty of murder under section 300 or culpable homicide not amounting to murder under exceptions to section 300 with reasons. (4 Marks)

b. A group of four college students used to stalk a girl Meera on a daily basis in college premises and on her way to home. They used to follow her, used to pass vulgar comments at public places and have approached her multiple times with proposal of love. Meera told them politely that she is not interested into any such thing and requested them to stop their unwarranted advances towards her. One day, the gang stopped her and showed her a few photos, videos on their phone in which she was taking bath, changing clothes. The girl went home, consumed poison and killed herself. Determine the liability of boys under various sections of IPC including that for 'abetment to suicide' with justification. (4 Marks)

c. A strikes his servant B with a small wooden stick with an intention to give him small punishment for not working properly since last couple of days. The blow hit servant on his damaged & weak lungs resulting into his death. Determine the liability of A. (2 Marks)
