Skit for Rural Camp on Social Issues and child marriage, child protection

Characters: Shantilal (husband), Mrs. Shantaben (Wife), Chotu (Shantilal's son), Kavita (Shantilal's daughter), Vighubhai (Chaiwala), Gogi (Child labour), Peter (Saheb) and Mayank: Social Worker

• This was basic script, it was later modified as per the needs of the villages and some issues were added impromptu.

Script adapted and written by: Mayank, Vighnesh and Devesh

Originally written in Gujarati Translated in English by Dr. Archana Tomar.

Scene one: Mr. Shantilal sitting in a chair was watching news bulletin on television

News reporter: Demonetization, rape, child labour, drug trafficking, child abuse and child marriages.

News highlights: As a result of demonetization a bhajiyawala (street food) became rich, in his account he got 350 crores in his account. Black money found. Ramgadh, seven year old child molested. Children involved in trafficking drugs. In Chuchapura village police raided the child marriage sight to stop it.

Shantilal: Oh ho.... Shanta did you see that? What is going on in this world? Where ever we see or hear about crime and criminal activities. We here of rape, child labour, drug trafficking as if this was less now we also have demonetization something new and different. Listen, my news bulletin is over but still your tea did not reach me. It seems i will have to send you back to your parent's house.

Shanta: Stop shouting and don't get angry like a monkey. Take this cup of tea and chill.

Shantilal: Your name is Shanta which means peace but your activities are like rock and very slow.

Shanta: ok ok stop blaming me and stop stone pelting of words on me. Finish your tea and go for the wedding. But tell me who is getting married today.

Shantilal: Ohhh! That peon in my school. What's his name? His son is getting married to that Chagan's daughter in the neighbouring village.

Scene two: Chotu enters

Chotu: Where do you plan to go daddy? To your school peon Ramla's place. That is where you want to go? But police has just raided that place and people are all running helter shelter. Police has booked both the families that is of bride and the groom. They have also booked the priest conducting the wedding ceremonies. Hall manager is also booked for the same crime of child marriage.

Shanta: Arrrre Sir You? It's our privilege that you visited our house.

Saheb: Ohh Bhabhi. Who is chotu talking about? Why and what for police came to our village? Chotu tell me what happened?

Shanta: Arrrrre! In our school we have that peon by name Ramlal his son was getting married today. But police came and arrested all the main members. Why this happened i cannot understand?

Chotu: Both the bride and groom are small that is why police came?

Saheb: Yes! Chotu, you are very smart and intelligent. Today i will tell you what happened and what should be done?

Shantilal: Yes yes tell us Saheb what happened and why?

Saheb: When a girls age is less than 18 and boys age is less than 21 years and they are married it is called child marriage. At this tender age when the children get married it is harmful as the children born out of such marriage are weak and their survival is at stake, similarly it is harmful for the mother also. Such babies do not have good physical, mental and emotional health. They also face risk of survival.

Shantilal: Saheb! Is there any punishment for such parents who get their underage children married of?

Saheb: Sure! There is punishment. Children cannot be considered responsible for their marriage, so they are not booked in the crime. But the adult members involved in the organization of the wedding and parents of children and family members can be sentenced for 2 years and penalty of one lakh rupees. It is so nice Shantilal you had a narrow escape, you also could have been booked for being party to such a crime.

Shanta: Look here! It was my tea that saved you or else you would have been in the police station or may be in jail.

Shantilal: Let us go and take a round in village. (As Mayank is walking in village street. Someone calls Mayank) Oh Mayankbahi how come you are in our village. Ok let us go together on the way we can talk also.

Mayankbhai: Where are we going in village? Which side?

Shantilal: Let us go! I would like to take some masala (tobacco with herbs and spices). I know you don't take masala you can have tea.

Mayankbhai: Arrrre! You want to go to heaven very fast. Leave this tobacco addiction, you are aware what can happen when you chew tobacco, it can develop mouth ulcers and mouth cancers also. Addictions have taken away many lives and disturbed many families it may be physical or financial, keep away from addiction.

Shantilal: O.k if you say so Mayankbhai i will try to leave it. O.k at least you will have tea.

Shantilal: (At the tea stall.) Vighubhai please give two cutting tea.

Vighubhai: Oh yes sir. Gogi "give two tea to shantilal"

Mayankbhai: (in lot of anger) Shantilal i don't want to take tea here.

Vighubhai: What happened sir? You are you boiling like tea in the teapot? What is the problem, have i done any mistake?

Shantilal: What happened?

Mayankbhai: Vighubhai you have employed a child to work for you? Are you aware employing children is a criminal offense?

Vighubhai: What are you saying? Tell me more i don't want to be a criminal. Tell me something more about child labour?

Mayankbhai: Ok i will explain to you more about child labour. Child labour means employing children under the age of 18 years. Any person engaged in any such task directly or indirectly by employing children. Like household work, taking care of siblings, taking cattle to grazing field, working in farmland, making (agarbatti) incense stick, family work, distributing newspapers, working on tea stall, bus stand, railway station, hotel, etc are places where children are seen working as child labour in places mentioned above.

Vighubhai: So, if the owner of the shop takes his child to work with him, will that be considered child labour?

Mayankbhai: Definitely yes! Intervening in the child's educational process is child labour. Employing a child for job can get imprisonment of 6 months to two year and penalty of 20 - 50 thousand rupees.

Vighubhai: Gogi. From tomorrow you are not coming for work. You go home i will make payment for your education. Please take care. Study hard.

Mayankbhai: (Says to Shantilal) O.k Shantilal i will take your leave.

Shantilal: Yes yes. Mayankbhai see you soon. My sister's daughter is coming from city i will be going to pick her up. She has also studied something related to law. (both move in different direction)

Scene three:

Shanta: Welcome welcome Chotu's Daddy. Day by day you are looking younger and younger.

Shantilal: Enough! don't try to say unnecessary good things about me. (goes to take water)

Shanta: Are you listening? In that city there is a big saree sale. So are we going?

Shantilal: on one hand there is demonetization, but your demands are increasing.

Shanta: You have that plastic card why you don't swipe it.

Shantilal: Oh my God that is known as ATM Card. You say anything that comes to your mouth. Now stop talking non sense. (Kavita enters the stage).

Kavita: Papa, papa leave all this ATM talks. Where did you go tell me?

Shanta: Your dad keeps going around in the entire village. He is always very busy in the village gossip. When he comes home he just shouts on any thing.

Kavita: Mom – Dad, what happened? Why do you fight on such small things? Now a days' cases of child abuse have increased.

Chotu: Sister so, are you talking about something that featured in Film Actor Amirkhan's show Satyamev Jayte in which they take up various social issues. Different kinds of exploitation and sexual abuse were covered. People talking or showing (ashleel) porn literature or passing comment or seeing some one differently or harassing a boy or a girl physically will also be considered as abuse. Any kind of bad touch will also be considered as abuse.

Kavita: Against sexual abuse government has brought out some strict rules. According to the law in 2012 a paedophile is likely to get strict jail for a period of 3 years or lifelong imprisonment can be given.

Chotu: Sister do you know Sajan? He eloped with Meena of our village. Was he caught? Has police arrested him.

Shanta: Why do you want to know that? Are you interested in eloping with someone?

Chotu: Nooooooo! Mummy i just wanted to know. Thats all.

Kavita: Look here bro. Child protection is a major task. Child protection is responsibility of all of us. Different types of children can be there: children in need of protection can be; orphan, destitute, missing child, physically handicapped, mentally handicapped. There can be other children in conflict with law; booked in the case of theft, pick pocketing, fighting, murder, rape etc. Such children who commit heinous crime are kept under observation so that they get social justice and are not labelled as criminal. District Child Protection Unit covers child protection, child labour, child marriage child abuse and child in conflict with law.

Chotu: In short can you say something.

Kavita: It is simple any one under the age of 18, if tries to take law in his or her hand. Needs protection and justice, needs steps to reprimand them and ameliorate their behaviour to become meaningful members of the society. Children are send to observation home.

Shanta: O Chotu, Chotu's Daddy and Kavita come for dinner. After having dinner go to sleep. Today we learnt a lot many things.
